**ORDINANCE NO. 2002-9**

**AN ORDINANCE INCREASING RATES FOR MONTHLY WATER CONSUMPTION OF OVER 2,000 GALLONS BY AMENDING ORDINANCE NO. 136, PASSED AND APPROVED HERETOFORE ON THE 17th DAY OF SEPTEMBER, 2002, BY THE TOWN OF BEASLEY, TEXAS; AND ESTABLISHING AN EFFECTIVE DATE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEASLEY, TEXAS:**

Section 1. That Ordinance No. 136 concerning the waterworks system of the Town of Beasley, as set out above, and as passed and approved heretofore on the 17<sup>th</sup> day of September 2002, is hereby amended to read as follows:

Rates for water are based on water consumed as registered on each customer's meter. The following rates per month shall be the rates charged for water furnished to water consumers within the corporate limits of the City of Beasley:

First 2,000 gallons	\$11.00 Minimum
All over 2,000 gallons	\$ 1.75 per 1,000 gallons
	or
	\$ 0.175 per 100 gallons or fraction thereof

For all service in excess of fifteen (15) days in each calendar month, a full monthly minimum charge plus usage shall apply. For fifteen (15) days or less in each calendar month a charge of fifty (50) percent of the minimum will be charged or \$11.00.

Section 2. That this Ordinance shall become effective October 01, 2002 after its passage and approval.

Effective October 01, 2002, the water and sewer rates for the City of Beasley will be as follows:


Water	\$11.00 first 2,000 gallons

All over 2,000 gallons	\$ 1.75 per 1,000 gallons


