ANNEXATION ORDINANCE No. 60

AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE TOWN OF BEASLEY, FORT BEND COUNTY, TEXAS, AND EXTENDING THE BOUNDARY LIMITS OF SAID TOWN SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN THE TOWN LIMITS, AND GRANTING TO SAID TERRITORY AND TO ALL FUTURE INHABITANTS OF SAID TERRITORY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID FUTURE INHABITANTS BY ALL OF THE ACTS AND ORDINANCES OF THE SAID TOWN.

WHEREAS, a petition for annexation has been duly signed and acknowledged by each and every person or corporation or governmental authority having an interest in or jurisdiction of the following described territory, to-wit:

A certain tract of land being a 6.9113 acre tract of land out of a 10.2932 acre tract of land in the I.& G. N.R.R. COMPANY Survey Section B. Abstract 351, Fort Bend County, Texas, said 10.2932 acre tract being that same certain called 10.31 acre tract of land described in Deed recorded in Volume 579, Page 289, Deed Records, Fort Bend County, Texas, and being more particularly described by metes and bounds in the Field Notes attached hereto marked EXHIBIT "A" and made a part hereof for all intents and purposes.

WHEREAS, said tract of land is contiguous and adjacent to the Town of Beasley, Texas, and is not more than one-half(\(\frac{1}{2}\)) mile in width, WHEREAS, after hearing such petition and the arguments for and against the same, the Board of Aldermen has voted by majority vote to grant such petition and to annex said territory to the Town of Beasley, Texas;

NOW THEREFORE, be it ordained by the Board of Aldermen of the Town of Beasley, Texas;

That the hereinabove described property be and the same is hereby annexed to the Town of Beasley, Texas; that the boundary limits of the Town of Beasley, Texas, be and the same are hereby extended to include the above described territory within the city limits of the Town of Beasley, Texas; that the same shall hereafter be included within the territorial limits of said Town; and, that said land and the future inhabitants hereof shall hereafter be entitled to all rights and privileges of other citizens of the Town of Beasley, Texas, and shall be bound by the acts and ordinances of said Town.

The Town Secretary is hereby directed to file with the County Clerk of Fort Bend County, Texas, a Certified copy of this ordinance.
