

ORDINANCE NO. 2024-11

AN ORDINANCE OF THE CITY COUNCIL OF BEASLEY, TEXAS CANVASSING AN ELECTION FOR THREE CITY COUNCIL MEMBER POSITIONS; AND MAKING OTHER PROVISIONS RELATED TO THE SUBJECT.

WHEREAS, the City Council held an election in the City of Beasley on May 4, 2024, for the purpose of electing three members of the City Council, and has authorized all matters pertaining to said election, including the ordering, giving notice, officers, holding, and making returns of the election; and

WHEREAS, the election officers who held said election have duly made the returns of the result thereof, and the returns have been duly delivered to the City Council;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEASLEY:

Section 1. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Ordinance for all purposes and are adopted as a part of the judgement and findings of the City Council.

Section 2. That the City Council officially finds and determines that said election was duly ordered, proper notice of said election was duly given, proper election officers were duly appointed prior to said election, said election was duly held, the City of Beasley has complied with the Federal Voting Rights Act and the Texas Election Code, due returns of the result of said election have been made and delivered, and the City Council has duly canvassed said returns, all in accordance with law and the ordinance calling said election.

Section 3. That the City Council officially finds and determines the following votes were cast at said election by the resident, qualified electors of the City of Beasley who voted at the election and result in the following:

Section 4. The following candidates are hereby declared elected to office and shall be issued a certificate of election:

Council Member	Cary Lamensky	2 year term
Council Member	Yvonne Meyer	2 year term
Council Member	Ernesto DeLeon	2 year term


Section 5. In the event any section, paragraph, subdivision, clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Beasley, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, or whether there be one or more parts.

Section 6. All provisions of the ordinances of the City of Beasley in conflict with the provisions of this Ordinance are hereby repealed, and all other provisions of the ordinances of the City of Beasley not in conflict with the provisions of this Ordinance shall remain in full force and effect.

Section 7. This ordinance shall be effective from and after the day of its adoption.
